The Board did not go into Executive Session.

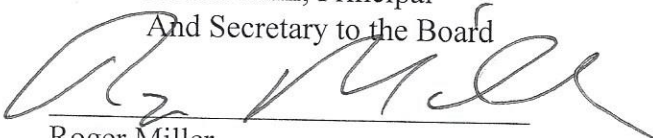
**ADJOURNED**
